Dear Jonathan Kiluk:

This office is handling the above matter on behalf of Budget Rent-A-Car Ontario Airport. You returned our client's rental vehicle, with damage which did not exist at the time of rental. You declined the purchase of the Collision Damage Waiver at the time of your rental. You agreed you would be responsible for all damage to the rental vehicle regardless of who caused it and even if the cause was unknown. You are therefore, legally and financially responsible for the damage sustained. In addition, our client has suffered administrative costs of \$100.00. You will note that the total amount of damage done to the rental car is \$ 689.62 including administrative fees.

It is possible that your own auto insurance carrier may cover you for this damage. Contact them immediately and furnish them with a copy of this letter. In the event that you did not carry insurance, it is mandatory that you contact this office to arrange to pay \$ 689.62. Please let us hear from you or your insurance carrier by May 23, 2012.

This debt is assumed valid unless you notify this office within (30) thirty days after receipt of this notice that you dispute the validity of the debt or any portion thereof. If you notify this office in writing within the 30 day period that this debt is disputed, in whole or part, we will obtain verification of debt or a copy of a judgment against you and mail a copy of such verification to you. Upon your written request within the thirty day period you will be provided with the name and address of the creditor if different from the current creditor.

OPT OEM or ALT OEM parts may reflect some specific, special, or unique pricing or discount. OPT OEM or ALT OEM parts may include "Blemished" parts provided by OEM's through OEM vehicle dealerships. Asterisk (*) or Double Asterisk (**) indicates that the parts and/or labor information provided by MOTOR may have been modified or may have come from an alternate data source. Tilde sign (~) items indicate MOTOR Not-Included Labor operations. The symbol (<>) indicates the refinish operation WILL NOT be performed as a separate procedure from the other panels in the estimate. Non-Original Equipment Manufacturer aftermarket parts are described as AM, Qual Repl Parts or Comp Repl Parts which stands for Competitive Replacement Parts. Used parts are described as LKQ, Qual Recy Parts, RCY, or USED. Reconditioned parts are described as Recond. Recored parts are described as Recore. NAGS Part Numbers and Benchmark Prices are provided by National Auto Glass Specifications. Labor operation times listed on the line with the NAGS information are MOTOR suggested labor operation times. NAGS labor operation times are not included. Pound sign (#) items indicate manual entries. Some 2010 vehicles contain minor changes from the previous year. For those vehicles, prior to receiving updated data from the vehicle manufacturer, labor and parts data from the previous year may be used. The Pathways estimator has a complete list of applicable vehicles. Parts numbers and prices should be confirmed with the local dealership.
